Terms and Conditions

- This agreement is between BPhotographed (photographer) and the Client (Bride & Groom) both represented by the signatures below.
- To confirm and secure your wedding date we require a payment of \$250. This payment is in the form of a retainer and once paid to BPhotographed your date is confirmed and we will not take any further bookings for your date.
- The prices are as per those advertised at the time the retainer is paid (as indicated above).
- The balance owing is required no later than 4 weeks prior to your wedding date.
- Enquiring if your date is available and informing BPhotographed that you would like to book, is not a confirmation of booking. Bookings and prices are only confirmed when the retainer is paid & signed agreement (this form) is provided.
- BPhotographed takes bookings on a "first in, first served basis" and is under no obligation to inform you if other customers also enquire after your date.
- In the event of a cancellation the retainer is non-refundable.
- In the event of a change of date or postponement the retainer is transferable provided the new date is available. Prices charged will be at the current rate, not the rate when originally booked.
- The photographic medium is digital
- High resolution images provided to the client are in .jpg format, may be un-retouched and are of original size (megapixels).
- The long term storage and care of the images is the responsibility of the client.
- The photographic services shall be as per the packages indicated above by a 'tick'.
- Should the client fail to give feedback or approve an album design within 3 months, the photographer will deliver the album as is.
- Changes to this agreement are to be made in writing and must be agreed on by both the client and photographer.
- Food and Beverage should be provided for the photographers (2 persons) for coverage that extends into the reception.
- The client retain full ownership and non-commercial reproduction rights to the photographs with the provision that the following points apply:
 - a) BPhotographed retains copyright and is able to use all photographs taken for promotional material and marketing purposes. This may include but is not limited to: portfolios, web site, album display, advertising, competitions & industry events
 - b) Should the clients wish to submit the photos to newspapers, magazines (etc) we request that we be made aware of this prior to publication. We will endeavour to provide the highest quality images to these publications.
- In the unlikely event that BPhotographed is unable to photograph your wedding, we will refund all monies paid and BPhotographed will assist in securing a replacement photographer.
